  - d. [NIH Competitive Modular](#) (S2S) Projects – Enter budget for each year; enter cumulative amounts for all Other than Personnel Costs (OTPS), graduate student costs, and all F&A excludable costs individually (e.g. equipment, patient care costs). Enter modules in modular budget tab.
  - e. [Federal Competitive Multi-Project / NIH ASSIST](#) (Non-S2S) Projects – Only enter Y1 budget; enter amounts in each project/core folder; enter cumulative amounts for all Other Costs, graduate student costs, and all F&A excludable costs individually (e.g., equipment, patient care costs).
  - f. [Federal Non-Competitive](#) (Non-S2S) Projects – Enter budget for upcoming year only; enter each key person individually, see data entry in 17d for all other costs.
  - g. [ISMMS as the Subawardee: All](#) (Non-S2S) Projects – Enter budget for upcoming year only. For non-federal, same data entry as 17a or 17b. For federal, same data entry as 17d or 17f.
