# I. Students and Post Graduates that Participate in Research at Mount Sinai

### Trainees

The NIH considers all students and post graduates participating on NIH training and fellowship grants as "trainees." Trainees are individuals in positions to acquire the skills needed to pursue their career goals. In addition, the NIH recognizes the dual role of students and post graduates as both trainees and employees on research grants (i.e., R/P/U series grants). The NIH writes, "Neither Pre-Docs nor Post-Docs need to be specifically appointed in 'training' positions to require recognition of this dual role." The NIH continues regarding postdocs, "Staff in postdoctoral positions engaged in research, while not generally pursuing an additional degree, are expected to be actively engaged in their training and career development under their research appointments as Post-Docs." For more information about these federal regulations, see the Uniform Guidance 200.400 (f) and the NIH policy memo, <u>NIH-OD-15-008</u>.

### Graduate Students (Predoctoral)

Graduate students pursuing a doctoral degree are also referred to as "predoctoral students" and "predoctoral fellows" as fellowship candidates. Graduate students (predocs) may be pursuing a PhD, a MD/PhD, or other equivalent doctoral level degree. Medical students, although technically predoctoral students, are not eligible for NIH training (T) and fellowship (F) awards nor are they eligible to receive direct compensation on NIH research grants.

- What School/Program do graduate students attend at Mount Sinai? Graduate School of Biomedical Sciences
- What is their primary affiliation on an InfoEd application? Graduate School or the department of their mentor
- What type of grants can predocs participate in or apply for?
  - Predocs may participate and receive direct compensation, health insurance, and tuition remission from research grants (e.g., NIH R01, P50, U19). Please refer to the predoc as a "Graduate Student" on the NIH application.
  - o They can participate as predocs on NIH National Research Service Award (NRSA) training grants (T series).
  - o They can apply for NIH NRSA predoctoral fellowships (F30, F31).
  - o They can participate as predocs on non-NRSA training grants.
  - o They can apply for non-NRSA predoctoral fellowships.

#### Medical Students

Medical students are students pursuing MD degrees. Medical students are graduate students as well as predocs but the NIH does not refer to them as such.

- What School/Program do medical students attend at Mount Sinai? Icahn School of Medicine at Mount Sinai
- What is their primary affiliation on an InfoEd application? Medical Education or the department of the PI
- Only medical students on a Scholarly Year fall under the guidance of this document. See the <u>Medical Students on a</u> <u>Scholarly Year</u> section for more information. Grant-related activities performed by medical students during their pre-clinical or clinical medical school years are not part of their academic training, and as such do not fall under the guidance of this document.
- What type of grants can medical students participate in or apply for?
  - o Medical students can participate in federal research, fellowship, and training grants
  - Medical students can <u>apply for</u> federal research, fellowship and training grants. Contact the <u>Medical</u> <u>Student Research Office</u> for guidance and availability.

# I. Students and Post Graduates that Participate in Research at Mount Sinai (continued)

- To be eligible for short-term, predoctoral research training positions, students must have received a baccalaureate degree by the beginning date of their NRSA appointment. In addition, students must be enrolled, in good standing, and must have completed at least one quarter or semester in a program leading to a clinical doctorate.
- Medical students can choose to take an extra year during medical school to do a year of full-time research a Scholarly Year (SY). SY students maintain student status at the school, but do not engage in any classes, clerkships, or other academic requirements.

### Postdoctoral Fellows (Postdocs)

Postdoctoral fellows are individuals holding a doctoral degree who are engaged in a temporary period of mentored research and/or scholarly training for the purpose of acquiring the professional skills needed to pursue their career path. Postdocs hold a MD, PhD, or other equivalent doctoral degree. The NIH also refers to postdocs with MD degrees who are pursuing further research training as "Research Clinicians."

- What School/Program do postdocs attend at Mount Sinai? Postdocs may take classes in the <u>Graduate School of</u> <u>Biomedical Sciences</u> as well as classes outside of Mount Sinai. Or they may not be taking any classes.
- What is their primary affiliation on an InfoEd application? The department in which they are appointed or employed.
- What type of grants can postdocs participate in or apply for?
  - o Postdocs may participate and receive compensation (i.e., salary/fringe) from research grants (e.g., NIH R01, P50, U19).
  - o They can participate as postdocs in NIH National Research Service Award (NRSA) training grants. Individuals in postgraduate clinical training, who wish to interrupt their studies for a year or more to engage in full-time research training before completing their formal training programs, are also eligible.
  - o They can apply for NIH NRSA postdoc fellowships (F32).
  - o They can apply for NIH NRSA senior postdoc fellowships (F33). Applicants must also have at least 7 years of relevant research or professional experience after receiving the doctorate and have established an independent research career.
  - o They can participate as postdocs in non-NRSA training grants.
  - o They can apply for non-NRSA postdoc fellowships.

#### **Residents**

Residents are medical school graduates who are in a period of post graduate training in a given specialty. Resident training can include clinical, educational and research opportunities.

- What is their primary affiliation on an InfoEd application? Department in which they are a resident.
- What type of grants can residents participate in or apply for?
  - o Residents may participate but do not receive compensation (i.e., salary/fringe) from research grants (e.g., NIH R01, P50, U19). Please do complete a <u>cost sharing form</u> and include the hospital fund number.
  - o They can apply for NIH NRSA postdoc fellowships (F32). Fellowships may not be used to support the clinical years of residency training. However, these awards are appropriate for the research fellowship years of a residency program. Research clinicians must devote full-time effort to their proposed research training and confine clinical duties to those activities that are part of the research training program.
  - o There may be other training/education programs (e.g. R25) offered by the different NIH Institutes/Centers.

# II. Medical Students on a Scholarly Year

Medical students can choose to take an extra year during medical school to do a year of full-time research called a Scholarly Year (SY). SY students maintain student status at the school, but do not engage in any classes, clerkships, or other academic requirements.

Medical students on SY are typically compensated from the department they are working with and that funding may be via a research grant.

When budgeting a Medical Student on a Scholarly year on a **federal Research grant** (e.g. NIH RO1, P50, U19; not T or F grants), please use the following amounts:

<u>Direct Compensation</u>: \$49,000 (Academic Year 2024-2025, through Jun 30, 2025) <u>Health Insurance</u>: \$6,700 (Academic Year 2023-2024, through June 30, 2024)

When budgeting a Medical Student on a Scholarly year on a **federal Training or Fellowship grant**, please contact the <u>Medical Student Research Office</u> for guidance.

# III. Graduate Students (Predoctoral) on Research Grants

Research grants are NIH's R, P, and many U series grants. Examples are R01, R21, P01, P50, U01, and U19 grants.

A. Graduate Students at Mount Sinai and Grant Eligibility: See Section I, "<u>Students and Post Graduates that Participate</u> <u>in Research at Mount Sinai</u>". Graduate students pursuing PhD or MD/PhD degrees follow the budgeting policy below.

#### B. Budget

#### 1. NIH Policy

Policy Summary: The maximum total compensation of graduate students on Federal grants cannot exceed the NIH Postdoc level 0, which the NIH currently sets at \$61,008. Total compensation includes: 1) direct compensation, 2) health insurance, and 3) tuition, fees.

#### 2. Graduate Student Compensation

Adapted from the 1/24/2024 Memorandum from Dean of the Graduate School of Biomedical Sciences and Dean for Academic and Scientific Affairs.

If there are funds remaining for tuition/fees, it is also possible to budget for less as appropriate. The per credit amount is \$1,250.

### 3. Instructions

- a. Direct Costs
  - i. In the Personnel section of a budget, enter the graduate student's name and % effort. Do not enter a graduate student <u>base salary</u> in the Personnel section.
  - ii. If the graduate student's % effort is less than 100%, you must prorate direct compensation, health insurance, and tuition in 2. above accordingly.
  - iii. In the Other Direct Costs section of the budget, enter the graduate student's <u>direct compensation</u>, health insurance and tuition/fees.
- b. Facilities and Administrative Fee (F&A) / Indirect Costs

Exclude tuition/fees from the facilities and administrative (F&A) fee calculation. Use Mount Sinai's federal research rate (On campus: 69.0%; Off campus: 26%). For further F&A information, see "Financial Information section in GCO's <u>Administrative Information Sheet</u>.

# **IV. Postdoctoral Fellows on Research Grants**

Research grants are NIH's R, P, and many U series grants. Examples are R01, R21, P01, P50, U01, and U19 grants.

A. Postdoctoral fellows at Mount Sinai and Grant Eligibility: See Section I, "<u>Students and Post Graduates that Participate</u> in <u>Research at Mount Sinai</u>". Post docs follow the budgeting policy below.

#### B. Budget

Adapted from Article 5 Compensation of the Collective Bargaining Agreement (12/23/23) between the ISMMS and the Sinai Postdoctoral Organizing Committee – UAW

Effective immediately, the minimum salary for a Postdoctoral Fellow is \$72,500. The minimum salary applicable to a particular Postdoctoral Fellow is based upon the number of past years that the Postdoctoral Fellow has held an appointment at Mount Sinai ("Mount Sinai Years of Experience") according to the following table:

### C. Budget

1. Direct Costs

Include these costs on your budget.

a. Stipend: \$28,224

The stipend helps to defray living expenses during the research and clinical training experiences. NRSA fellowship recipients are not considered employees of the sponsoring institution and therefore do not receive salaries or fringe benefits.

The stipend is required to be supplemented by PI/departmental funds up to \$49,000 effective 7/1/2024. This supplementation is <u>not</u> reflected on the budget and does not require a cost sharing form to GCO, but the availability of funds should be considered by the PI/Department when submitting applications.

c. Childcare Costs: \$3,000

NIH will begin providing childcare support to recipients of NRSA fellowships, on or after April 8, 2021 on new applications, RPPRs, and as administrative supplements. Refer to NIH Notice <u>NOT-OD-21-069</u> and <u>NOT-OD-21-070</u> and the <u>NIH FAQs on Childcare Costs</u> for instructions and more information. ## V. Predoctoral Fellowships (continued)

d. Institutional Allowance: \$4,750

Institutional allowance covers health insurance assuming fellow does not opt out. Mount Sinai's health insurance cost is \$9,999 eff. 7/1/2024. If the fellow opts out of receiving health insurance, other allowable costs would be research supplies, books, and travel to scientific meetings.

- 2. Facilities and Administrative Fee (F&A) / Indirect Costs This cost is not allowable.
- 3. Instructions for Competitive Applications (e.g., New, Resubmission Applications, Competitive Renewals) There are <u>two</u> places to enter budget information in the System to System InfoEd application.
  - a. In the InfoEd Budget tab, please enter participant stipend, tuition and fees, and institutional allowance. Information from this tab is then exported to the total funds requested box (#15. Estimated Funding) on the NIH SF 424 Face Page. GCO will correct this tab as needed.
  - b. In the S2S Forms tab, click on the Edit Icon () of "PHS\_Fellowship\_Supplemental\_2\_0" form. Then go to Section E "Budget" and complete the tuition and fees section of this supplemental form. No additional budget information is required in this section. Besides the total funds requested on the NIH SF 424 Face Page, the NIH only sees the tuition and fees amount. The NIH will determine the stipend and institutional allowance at the time of the award and will include all budget categories in the Notice of Award.

### D. Post Award

1. Stipend Increases

The stipend schedule effective at the time of award determines the amount of stipend. The same amount remains in effect until the award is renewed. The NIH adjusts awards on the award notice anniversary date. For example, if the award was made July 1, 2023, the fellow will receive his/her stipend in accordance with the FY2023 stipend scale for the entire period of his/her appointment. If the fellow remains on the grant for another year, he/she will receive the higher stipend amount when reappointed in July.

2. Tuition and Fees

The NIH pays for 60% of Tuition and Fees, up to \$16,000 for PhDs and \$21,000 for dual degrees.

3. Rebudgeting

Stipend and tuition/fees may not be used for other purposes except under unusual circumstances and then only with the prior approval of the NIH awarding Institute/Center.

4. Activation

Predocs must sign an <u>Activation Notice (PHS 416-5)</u> as of the day the fellow begins training. The individual may activate the fellowship on or after the issue date of the NoA up to the latest activation date shown in the NoA (generally 6 months after the award issue date). This form is required for the first year only. See Reporting Requirements > Activation Notice section 11.2.11 in the <u>NIH Grants Policy Statement</u> for complete information.

Please include Raj Appavu (e-mail: <u>Raj.Appavu@mssm.edu</u>; Tel: 646-605-4023) from Sponsored Projects Accounting as the Institutional Business Official on the form. After obtaining the required signatures, please send the signed original to the awarding agency provided in the NoA.

### 5. Termination

A Termination Notice (PHS 416-7) must be submitted within 30 days of the termination date, even if the predoc is not available for signature. For early terminations, the completed form will be required immediately upon receipt

of notification. See Reporting Requirements > Termination Notice section 11.2.11.3 in the NIH Grants Policy Statement for complete information.

The use of the ERA Commons' xTrain module is mandatory for electronic preparation and submission. See Termination Process Flow (p.7) and the xTRAIN Termination of Fellowships Quick Reference Guide for more information. Please select Raj Appavu as the Business Official. The fellow routes the application to the Mentor (i.e., Sponsor) for approval. After approving, xTRAIN routes to the Business Official as the next reviewer who submits to the agency.

The stipend helps to defray living expenses during the research and clinical training experiences. Fellowship recipients are not considered employees of the Federal government or the sponsoring institution and therefore do not receive salaries or fringe benefits.

As per the Collective Bargaining Agreement between the ISMMS and the Sinai Postdoctoral Organizing Committee – UAW (ratification date 12/23/23), effective immediately all stipend levels must be supplemented to a minimum of 72,500 from appropriate non-federal sources. This supplementation is <u>not</u> reflected on the budget and does not require a cost sharing form to GCO, but the availability of funds should be considered by the PI/Department when submitting applications.

### b. Tuition and Fees

#### Per Credit Amount: \$1,250

Determine tuition and fees based on # of credits and per credit amount above if Postdoc is enrolling in a course at Mount Sinai or check with the Graduate School for the cost of degree programs and other information. Postdocs can take courses outside of Mount Sinai so be sure to check that the rates of the institution. Always request the full amount in the grant application and progress report. Costs associated with tuition and fees are allowable only if they are required for specific courses in support of the research training. NIH will contribute to the combined cost of tuition and fees at the rate in place at the time of award.

c. Childcare Costs: \$3,000

NIH will begin providing childcare support to recipients of NRSA fellowships, on or after April 8, 2021 on new applications, RPPRs, and as administrative supplements. Refer to NIH Notices <u>NOT-OD-21-069</u> and <u>NOT-OD-21-070</u> and the <u>NIH FAQs on Childcare Costs</u> for instructions and more information. AHRQ also allows for child care costs. See <u>NOT-HS-22-013</u> for more information. Also refer to <u>News Release: FY2024 Increases for Pre-and Postdoctoral Scholars</u>.

d. Institutional Allowance: \$12,400

Institutional allowance covers health insurance assuming fellow does not opt out. Other allowable costs would be research supplies, books, travel to scientific meetings, and costs for administering fellowship if there were funds after health insurance is paid.

- 3. Instructions for Competitive Applications (e.g., New, Resubmission Applications, Competitive Renewals) There are <u>two</u> places to enter budget information in InfoEd.

     Information from this tab is then exported to the total funds requested box (#15. Estimated Funding) on the NIH SF 424 Face Page. GCO will correct this tab as needed.
  - b. In the S2S Forms tab, click on the Edit Icon (a) of "PHS\_Fellowship\_Supplemental\_2\_0" form. Then go to Section E "Budget" and complete the tuition and fees section of this supplemental form. No additional budget information is required in this section. Besides the total funds requested on the NIH SF 424 Face Page, the NIH only sees the tuition and fees amount. The NIH will determine the stipend and institutional allowance at the time of the award and will include all budget categories in the Notice of Award (NoA).

### D. Post Award

1. Stipend Increases

The stipend schedule effective at the time of award determines the amount of stipend. The same amount remains in effect until the award is renewed. The NIH adjusts awards on the award notice anniversary date. For example, if the award was made July 1, 2023, the fellow will receive his/her stipend in accordance with the FY2023 stipend scale for the entire period of his/her appointment. If the fellow remains on the grant for another year, he/she will receive the 2024 stipend amount when they are reappointed in July 2024.

2. Tuition and Fees

For related training, the NIH pays for 60% of the level requested by the institution (i.e., amount in place at time of award), up to \$4,500. If the postdoc is in a formal degree-granting training, the NIH pays for 60% of the level requested by the applicant institution, up to \$16,000 per year. As noted previously, request the full amount in the application. The NIH will apply the formula once awarded and will include this amount in the NOA.

3. Rebudgeting

Stipend and tuition/fees may not be used for other purposes except under unusual circumstances and then only with the prior approval of the NIH awarding Institute/Center.

### 4. Activation

Postdocs must sign an <u>Activation Notice (PHS 416-5)</u> as of the day the fellow begins training. The individual may activate the fellowship on or after the issue date of the NoA up to the latest activation date shown in the NoA (generally 6 months after the award issue date). This form is required for the first year only. See Reporting Requirements > Activation Notice section 11.2.11 in the <u>NIH Grants Policy Statement</u> for complete information.
